# Staples city budget starts with slight increase By Mark Anderson Staples Police budget was

The Staples City Council discussed the first draft of the city budget at a special meeting Aug. 17.

City Administrator Jerel Nelsen said the draft document shows a two percent levy increase. He said the draft document will be tuned up for the council's preliminary approval in September.

The budget includes an increase of \$28,500 in Local Government Aid (LGA) for a total of \$753,472. More revenue will come from a full year of tax increments from the Cardinal Pines apartments and the Staples Eye Clinic/Lakeland Dental building.

Major factors in the budget include an increase in salary and reduction of interest earnings. The increased with the addition of one full time position.

The budget included several one time payments, including turnout gear for new firefighters, paving at Dower Lake and Airview Drive, improvements to the Lincoln Park playground, new security cameras for city buildings, a new bucket truck for the light department and automatic meter reading infrastructure. One big project will be replacing the water main on Minnesota Ave. SE. The wastewater treatment plant currently being constructed is spread between this year's budget and next year's.

Nelsen said the budget is largely status quo to maintain the Staples Community Center. "We are at the point where we are going to have

# Horse needs to be put down after wolf attack

A horse in the Leader area was euthanized after it was attacked by a wolf on Aug. 16, a few miles south of Leader. Julie Rempel said the horse belonged to her daughter, Grace Koskiniemi. They came home and found the horse, named

Blue for its blue eyes, bleeding with extensive injuries.

Rempel said there are many reports of wolves in the area, but they are not allowed to do anything about it until a farm animal is attacked by them. "I would like to bring attention to this issue.," Rempel said.

Bill Paul is a federal trap-

per for the USDA who came in to trap the wolves that may have attacked the horse.

"We get a couple of complaints a year in the Leader area, and some additional ones in the Pine River area," said Paul.

Paul said it is rare for a wolf to attack a horse, as

# COVID-19 taking hold in Wadena County

The latest report from the Minnesota Department of Health shows 12 new cases of COVID-19 in Wadena County for the week of Aug. 16-23, the first double digit jump for the county. Wadena County still has a relatively low total of 41 cases detected since the pandemic started.

Two care facilities in Wadena County have either staff, visitors or residents who have tested positive for COVID-19. They are Green Pine Acres and Providence Villa. The Department of Health only lists facilities that have had a case in the past 28 days. No other facility in the four county area is cur-

rently listed.

Todd County continued the slow spread of the virus with seven new cases in the week, Morrison County had five and Cass County pine

Otter Tail County had another large jump during the week with 25 new cases and Crow Wing County, the Brainerd area, had 19 new cases.

Of the 89 cases in Cass County, three have resulted in the death of the patient. Todd County has two deaths from the disease, Morrison has one and Wadena County



### **Todd County offers** grant monies for businesses required to close by COVID-19 orders

During their regular meeting on Aug. 4, 2020, the Todd County Board of Commissioners approved several board actions related to the CARES Act funds of \$2,981,853 plus the supplement of \$18,232.

After discussion, the board approved setting up a Small Business Grant Program with \$600,000 of the funds with individual grants of up to \$5,000 each.

While initially the board was only going to approve \$500,000, they added another \$100,000 so they could include home based busineses that were affected.

There were several stipulations and guidelines for this first round of grants which began the application process on August 10 and end August 28, 2020.

The program will run through the Todd County Economic Development office which the county board felt was needed for a dedicated person to do the paperwork of the grant.

It's expected that additional programs will be created for economic support until CARES Act Coronavirus Relief Funds are spent, up to December 30, 2020.

They approved CARES Act Coronavirus Relief Funds (CRF) for the acceptable use of creating programs related to economic

support. The program is designed to reimburse the costs of business interruption caused by the required closures to small businesses who meet the criteria of the application. Business that stayed open during the pandemic are not eligible during this first round of grants.

The board said there was a possibility of second round grants that could reach and help businesses that were required to remain open.

The board reviewed a list of expenses already incurred.

Commissioner Barb Becker said she would like to see a running total so they always know where they're at with the funds.

The board approved these necessary incurred expenses from March 1, 2020 through June 30, 2020 for CARES Act CRF reporting and authorize Coordinator Chris Pelzer to approve ongoing necessary expenses through December 30, 2020. The approved expenses so far are \$98,281.

- Approved the budgeted request to hire Shawn Karnes to fill the mainte-

nance tech position at \$25.61. It is hoped that this position will reduce the amount of overtime in the maintenance department.

 Acting as Ditch Authority, the board approved a Hold Harmless Agreement Petition from Mike Irlbeck to maintain approximately 6,360 feet of County Ditch 27 in Wykeham Township.

· Acting as Ditch Authority, the board approved a Hold Harmless Agreement Petition from Jeff Seurer to install a 24" x 30' culvert for a private crossing on County Ditch 35 in Bartlett Township, Section 34.

 Because of the rate increase this year and the unanswered questions received from Minnesota Counties Intergovernmental Trust (MCIT) for coverage in the future, regarding the Prairie Lakes Municipal Solid Waste Authority (PLMSWA) (incinerator facility in Perham), the board approved sending a letter of support to MCIT with the following requests:

1. MCIT allow PLMSWA and the other three Waste To Energy (WTE) related MCIT members to obtain property insurance and equipment breakdown insurance coverage through other brokers; and continue to receive general liability and workers compensation coverage through MCIT.

2. If we, the MCIT WTE members, are successful in obtaining desirable coverage through a third party risk management consultant, MCIT will retain and reimburse our third party consultant and continue WTE coverage in 2021 with the insurance package.

3. MCIT allow Non-MCIT (Minnesota) counties that own WTE facilities to obtain property and/or equipment breakdown insurance through MCIT without obtaining general liability and workers' compensation insurance through MCIT.

#### 50 Years Ago - 1970



#### Body cams could be coming

to decide what we are going to do" with the building, said Nelsen. He said that would take a separate meeting to discuss all the options for the community center.

Looking into the future, Police Chief Melissa Birkholtz said the department may be required to purchase body cameras to wear on duty. "I don't think any of us are against wearing them, it's all the other things that go along with it," said Birkholtz

She said videos collected by the body cameras would need to be stored by expensive data cloud storage. The department would have to do more to comply with information requests and would have to try and redact any private information stored on the videos, all of which would take a lot of time. On the positive side, Birkholtz said places where police cameras are worn have a lot fewer police complaints and it can help with prosecuting offenders.



# False reports very rare for domestic, sexual violence

We have recently heard some concerns about victims of domestic and sexual violence falsely reporting, so I took some time to do some research and found some interesting statistics to share with you in that re-

Studies completed by reputable resources, estimate that less than two percent of all domestic violence and sexual assault cases are falsely reported. So, if my math serves me correctly, that tells me that 98 percent of victims of these behaviors are making legitimate, truthful reports. One important factor to take into consideration is that nearly 70 percent of all domestic violence incidents and 90 percent of sexual assaults are NEVER reported, and those that come forward have reported that they have been assaulted as many as 35 times prior to making that first report. Fear and intimidation has a tendency to encourage silence. Other factors like fear of retaliation, of losing their children, housing, and their economic stability play a huge roll, as well as our current pandemic sit-

uation. Victims often selfblame, are ashamed and are asked why they stayed, or "why didn't you just leave"? Perhaps we need to be asking the perpetrators of this violence, "Why did you do this"? Sexual assault and domestic assault are acts of power and control of one individual over another.

The decision to end a relationship with an abusive partner is one of the most dangerous and defining decisions that individual will ever make. This person, whether male or female is standing up, often putting themselves, as well as friends and family in added danger. For some it means losing their home, financial stability, transportation, family members, and the list goes on.

Very rarely is someone reporting an incident of domestic or sexual violence falsely reporting, and those few that do are truly adding to the harm for real victims of these crimes. A false report puts doubt in the minds of law enforcement, and prosecutors, resulting in victim credibility being questioned. To anyone that has been victimized for real, there is only one objective in their mind and that is to be able to live in safety. There is no big financial pay off, no promise of anything,

except hopefully some justice and accountability for the offender, and a new life without fear and violence, which we are all entitled to.

Perhaps, as a society we just don't want to accept that someone we know, a neighbor, friend, or a family member is capable of the violence that has occurred and been reported. Often times when watching a news report of a domestic homicide, we hear the comment, "he/she seemed like such a nice person." We never know what goes on behind closed doors. This violence is upsetting to our sense of safety and security in our own home and in our communities.

One of the first and most vital comments a victim needs and wants to hear, is "I believe you." Contact Hands of Hope Resource Center if you or someone you know is dealing with sexual assault or domestic violence. We are here to listen and offer resources. 

# **Hungry Minnesotans** can get help

Everyone needs help sometimes. That is especially true for Minnesotans who have lost their jobs or have been hit hard by COVID-19, especially those in Black. Asian, Latino, Native American and immigrant communities.

As I have listened to community members across the state, one of the pressing concerns I've heard is that Minnesotans are struggling to put food on their tables. The onset of COVID-19 has only heightened that need. In June, more than 426,000 Minnesotans accessed the Supplemental Nutrition Assistance Program – an increase of 11 percent over this same time last year - and more than 345,000 Minnesotans visited food shelves – an increase of 20 percent over last year at this

With the end of the federal Pandemic Unemployment Compensation funds to help pay for food, we expect hunger to surge. At the Minnesota Department of Human Services, we're working alongside our partners in counties, tribes, community and nonprofit organizations to help meet the needs of people across the state who may be struggling to put food on the table

for their families.

#### Help is available

Supplemental Nutrition Assistance Program: With SNAP, Minnesotans who meet income eligibility guidelines can get help to pay for groceries. Administered by counties and tribes, SNAP is an important supplement to families' food budgets. They can apply online via https://applymn.dhs.mn.gov, and now use their benefits to purchase food online through Walmart and Amazon.

Minnesota Family Investment Program: MFIP is a resource for families with children. Based on income eligibility guidelines, MFIP can include SNAP benefits in addition to cash benefits for living expenses and additional food. Minnesotans can apply for both SNAP and MFIP via https://applymn.dhs.mn.gov, and will need to complete an interview in person or over the phone with their county or tribe. Minnesotans who already receive food and cash assistance benefits must reapply annually. For 20,000 Minnesotans who recently received a notice in the mail, that renewal is due by Aug. 31 for September benefits.

Minnesota food shelves: Minnesotans with low incomes can access free food including some items that meet specific cultural diets – and other household items at food shelves in their

communities. The Department of Human Services supports Minnesota's seven regional food banks and more than 300 food shelves, all of which serve people regardless of their immigration status. Accessing food shelves does not count as public assistance under the federal Public Charge Rule.

# Arts community devastated by COVID-19 pandemic

I am reaching out to share some news on the current programs and services of the Five Wings Arts Council. We can call it a Situational COVID-19 Update," if you will.

What we know right now is the Coronavirus pandemic has been extremely challenging and outright devastating to our arts community. Five Wings understands and empathizes with the struggles of our regional artists and arts organizations. At the onset of the crisis, Five Wings responded with an immediate shift in our grant process to allow for application and report deadline extensions, removal of match requirements, vast flexibility in cancellations and postponements, and alternate deliverables. We also offered Zoom Video

From Five Wings Arts Council Licenses to organizations, a ganizations, Five Wings has newsletter Fast Track Professional Deshifted enough resources to eral networking video-chats, and facilitated a no-fee custom tailored learning experience on how to bring your arts programming to a digital platform.

Our intent is to be as flexible and supportive with our allotted funding as possible while maintaining the accountability and transparency that comes with public dollars. We know there is a vast need out there in our arts community for additional financial support and certainly wish we could do more right now. But, as a recipient of funds derived primarily from the state coffers, Five Wings is currently in a holding pattern.

Our new fiscal and grant year started July 1, but we have not yet received a final word on the amount of our state allocation. We do know a few things - Five Wings will likely be cut about 15% (potentially more) and the state will transfer the money to us at a much slower rate than a typical year. We are also being advised that funding for the next two years is also likely to be reduced due to both a downturn in sales tax collected and COVID-19 related expenses incurred by the state.

With that said, it is not all doom and gloom! The Five Wings Board and Staff is dedicated to our mission of encouraging, promoting, and supporting the arts and we are certainly in this together with all of you for the long haul. We currently have funding available in our Individual Artist pool and in an effort to help support and stabilize our established community arts oral Operating Grant program as normal without reductions in funding amounts from the previous year.

Unfortunately, we were forced to cancel our regular July 15 round for Community Arts Access Projects and our School Project Grants are on a temporary hiatus. We are hoping that we will still be able to offer an October 15 grant round for Community Arts Access Proiects, but that will depend on the timing of payments (if any) from the state. We are prohibited by state law to award any grants until we have a contract in place with the state governing authority.

Rest assured, that as soon as we get the word, Five Wings will be ready to roll with a revised deadline to accommodate as many projects as we can! Please stay tuned to www.fwac.org and our Facebook page for the latest updates. We also pledge to be flexible in working with you as you navigate the CVOID-19 realities of being an artist, arts presenter and producer. It has been inspiring to see the creativity and determination of all of you during these times.

In the meanwhile, please know that the Five Wings Staff is here to help, however we can. We are truly your advocates! Do not hesitate to reach out with any questions, comments, or concerns that relate to your local arts group or as an individual artist. We are continuing to work on your behalf to encourage, support, and promote the arts in our region.



# Maynard Reece was the original duck stamp 'big winner'

Thoughts of our mortality and the preciousness of life are much closer during these days of the COVID-19 pandemic, which is today's version of the Spanish flu that killed so many at the close of, and shortly after, World War I.

Too many lives are ending prematurely, so it seemed a poetic contrast to learn that—at the time of his death mere weeks ago—wildlife artist Maynard

Reece had reached the century mark, one of the most accom. plished wildlife artists of these or any times. Reece was born, and lived most of his productive 100 years in neighbor-

neighboring Iowa; a lion's share of it in Des

When Minnesota hunters and art aficionados talk of fame in the wildlife sector of the art world, they're likely to think first of the trio of Minnesota brothers—Joe, Jim, and Bob Hautman—who together have won 13 federal Migratory Bird Hunting and Conservation stamp contests. Brothers Joe and Jim have each won five of what we loosely call the "duck stamp" competition.

For those who are not waterfowl hunters, in the year following the competition the winning image appears on the postage-sized paper stamp that duck and goose hunters are required

to carry on their person when they hunt waterfowl. Since the inception of the stamp in 1934, some \$800 million has been raised for wetlands conservation and restoration by stamp sales. Even many who do not hunt also purchase them, because the habitat preserved with stamp proceeds benefits many nongame

creatures, as well.

But, with all due respect to the Hautmans—and to the other Minnesota artists who have won the federal duck stamp competition over the last 86 years—it was Maynard Reece who first accomplished the "five-peat," winning it five times—in 1948, 1951, 1959, 1969, and 1971. That record stood for more than four decades.

Reece's talent was evident early; at age 12 he won a contest at the Iowa State Fair with a pencil drawing of mallard ducks. Practice and study led first to a career as an illustrator, receiving such kudos as being hired by Life Magazine to produce images of freshwater and saltwater fish for this then-prominent national publication. Sports Illustrated and the Saturday Evening Post were among his other trophy-level clients. Reece clearly had talent that took him beyond the narrow niche of artwork that tends most often to decorate gun rooms and man-caves.

Maynard Reece's talent

eventually made it possible for him to focus his professional skills full-time on Nature subjects, rather than as a general illustrator. He was able to concentrate on original artwork and magazine commissions, and limited edition prints of his work, much of it linked to his success in state and federal stamp competitions. Reece was so prolific that there are collections of his work in a pair of books, entitled The Waterfowl Art of Maynard Reece, and The Upland Bird Art of Maynard Reece. No doubt these will be more highly prized now that Reece has picked up his decoys for the last time, and rowed his duck boat into the sunset.

One of the positive features of Reece's art—in this writer's opinion, anywayis the fact that you can't look at most of his paintings—which might feature ducks, pheasants, geese, or quail and the environments in which they're found and say with certainty "that's by Maynard Reece." In other words, his painting style didn't overshadow his subjects. The creatures and the environments in which they were placed were well-executed and "right," without the stylistic exaggeration or uninspired photo-realism that reveal some artists' identities. There are exceptions,

of course, some that we've come to treasure, in the same way we appreciate

the impressionists in the broader world of fine art. Les Kouba is one. His artwork can usually be recognized immediately. He aimed for atmosphere, nostalgia, and for an "I've been there" reaction from his art's viewers. More often than not these objectives took priority over biological accuracy or intricate detail. Despite this very different approach, both Kouba's artwork and his quirky appearance became iconic to Minnesotans.

Maynard Reece was clearly an artist with a sense of humor, as well as having talent largely undiminished by age. He created a painting with 80 mallards in it for his 80th year, and did the same in the years he attained ages 85 and 90; these paintings have 85 and 90 mallards, respectively. Sadly, there is no painting with 100 mallards in it to mark this, his 100th year, and the year of his passing.

There are plans to hold a celebration of Maynard Reece's life when the COVID-19 pandemic loosens its grip on the country, according to his obituary. As meaningful as such gatherings and the sentiments shared at them can be, it's hard to imagine a more enduring memorial than the wide-ranging and widely acclaimed wildlife artwork created by this, the original five-peat duck stamp winner.





Once a wolf attacks livestock, "They do keep coming back," said Paul. "Hopefully they won't have losses again

Paul said if a farmer has livestock or a dog killed, they can set traps to remove the problem wolves. The USDA also has a compensation program for wolf damage to livestock.

On the first night of trapping, Paul bagged an adult female wolf, but he said evidence shows more wolves were involved so he will keep trying to remove them.


