A state primary election will be held on August 13, 2024, to nominate candidates for the following offices which are to be voted on at the general election to be held November 5, 2024. The State Partisan Primary Election Ballot will include the offices of U.S. Senator and U.S. Representative Congressional District 8.

The State and County Nonpartisan Primary ballot will include a Cass County Commissioner race for District 3 only.
